

# **Terms & Conditions**

- 1. Introduction
  - a. These terms and conditions shall govern your use of our website.
  - b. By using our website, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not use our website.
  - c. If you register with our website, submit any material to our website or use any of our website services, we will ask you to expressly agree to these terms and conditions.
  - d. Our website uses cookies; by using our website or agreeing to these terms and conditions, you consent to our use of cookies in accordance with the terms of our privacy and cookies policy.
- 2. Copyright Notice
  - a. Copyright (c) Winaim Limited.
  - b. Subject to the express provisions of these terms and conditions:
    - i. we, together with our licensors, own and control all the copyright and other intellectual property rights in our website and the material on our website; and
    - ii. all the copyright and other intellectual property rights in our website and the material on our website are reserved.
- 3. License to use website
  - a. You may:
    - i. view pages from our website in a web browser;
    - ii. download pages from our website for caching in a web browser;
    - iii. print pages from our website;
    - iv. stream audio and video files from our website; and
    - v. use our website services by means of a web browser, subject to the other provisions of these terms and conditions.
  - b. Except as expressly permitted by Section 3.1 or the other provisions of these terms and conditions, you must not download any material from our website or save any such material to your computer.
  - c. You may only use our website for your own personal and business purposes, and you must not use our website for any other purposes.
  - d. Except as expressly permitted by these terms and conditions, you must not edit or otherwise modify any material on our website.

## 4. Downloadable content

#### 5. Acceptable use

- a. You must not:
  - i. use our website in any way or take any action that causes, or may cause, damage to the website or impairment of the performance, availability or accessibility of the website;
  - ii. use our website in any way that is unlawful, illegal, fraudulent or harmful, or in connection with any unlawful, illegal, fraudulent or harmful purpose or activity;

  - vi. violate the directives set out in the robots.txt file for our website; or

- b. You must not use data collected from our website to contact individuals, companies or other persons or entities.
- c. You must ensure that all the information you supply to us through our website, or in relation to our website, is true, accurate, current, complete and non-misleading.
- 6. Registration and accounts
  - a. To be eligible for an individual account on our website under this Section 7, you must be at least 18 years of age and resident in the United Kingdom.

  - c. You must notify us in writing immediately if you become aware of any unauthorised use of your account.
  - d. You must not use any other person's account to access the website.
- 7. Cancellation and suspension of account
  - a. We may:
    - i. suspend your account;

    - iii. edit your account details, at any time in our sole discretion without notice or explanation.
  - b. You may cancel your account on our website using your account control panel on the website.



## 8. Testimonials

- a. This Section 10 governs all testimonials relating to our business that you send to us, whether through our website, by email or otherwise.

  - ii. publish your testimonials on our website and in such other print and electronic media as we may determine from time to time; and
  - iii. publish, together with each testimonial, the name and logo of the business and the name and job title of the person giving the testimonial.
- d. You grant to us the right to sub-license the rights licensed under Section 10.3.
- e. You grant to us the right to bring an action for infringement of the rights licensed in Section 10.3.
- 9. Recruitment
  - a. We may from time to time publish, on our website, advertisements for job opportunities within our organization.
  - b. We reserve the right to update information concerning the job opportunities posted on our website (including without limitation job descriptions, candidate requirements, application procedures and application deadlines).
  - c. We do not guarantee that we will consider all applications for job opportunities; nor do we guarantee that persons meeting the published candidate requirements will proceed to the next stage of the recruitment process. However, we will ensure that the application process is conducted in accordance with all applicable laws, including applicable discrimination laws.
  - d. We will treat all information forming part of a job application as confidential and in accordance with our privacy and cookies policy.
  - e. You should keep a copy of all information that you supply as part of a job application.
- 10. Your content: license
  - a.   - b. You grant to us a worldwide, irrevocable, non-exclusive, royalty-free licence to use, reproduce, store, adapt, publish, translate and distribute your content in any existing or future media.
  - c. You grant to us the right to sub-license the rights licensed under Section 11.2.
  - d. You grant to us the right to bring an action for infringement of the rights licensed under Section 11.2.
  - e. You hereby waive all your moral rights in your content to the maximum extent permitted by applicable law; and you warrant and represent that all other moral rights in your content have been waived to the maximum extent permitted by applicable law.
  - f. You may edit your content to the extent permitted using the editing functionality made available on our website.
  - g. Without prejudice to our other rights under these terms and conditions, if you breach any provision of these terms and conditions in any way, or if we reasonably suspect that you have breached these terms and conditions in any way, we may delete, unpublish or edit any or all of your content.



# 11. Your content: rules

- a. You warrant and represent that your content will comply with these terms and conditions.
- b. Your content must not be illegal or unlawful, must not infringe any person's legal rights, and must not be capable of giving rise to legal action against any person (in each case in any jurisdiction and under any applicable law).
- c. Your content, and the use of your content by us in accordance with these terms and conditions, must not:
  - i. be libellous or maliciously false;
  - ii. be obscene or indecent;
  - iii. infringe any copyright, moral right, database right, trade mark right, design right, right in passing off, or other intellectual property right;
  - iv. infringe any right of confidence, right of privacy or right under data protection legislation;
  - v. constitute negligent advice or contain any negligent statement;
  - vi. constitute an incitement to commit a crime;
  - vii. be in contempt of any court, or in breach of any court order;
  - viii. be in breach of racial or religious hatred or discrimination legislation;
  - ix. be blasphemous;
  - x. be in breach of official secrets legislation;
  - xi. be in breach of any contractual obligation owed to any person;
  - xii. depict violence;
  - xiii. be pornographic, lewd, suggestive or sexually explicit;
  - xiv. be untrue, false, inaccurate or misleading;
  - xv. consist of or contain any instructions, advice or other information which may be acted upon and could, if acted upon, cause illness, injury or death, or any other loss or damage;
  - xvi. constitute spam;
  - xvii. be offensive, deceptive, fraudulent, threatening, abusive, harassing, anti-social, menacing, hateful, discriminatory or inflammatory; or
- xviii. cause annoyance, inconvenience or needless anxiety to any person.
- 12. Report abuse
  - a. If you learn of any unlawful material or activity on our website, or any material or activity that breaches these terms and conditions, please let us know.

- 14. Limitations and exclusions of liability
  - a. Nothing in these terms and conditions will:
    - i. limit or exclude any liability for death or personal injury resulting from negligence;
    - ii. limit or exclude any liability for fraud or fraudulent misrepresentation;
    - iii. limit any liabilities in any way that is not permitted under applicable law; or
    - iv. exclude any liabilities that may not be excluded under applicable law.
  - b. The limitations and exclusions of liability set out in this Section 14 and elsewhere in these terms and conditions:
    - i. are subject to Section 14.1; and
    - ii. govern all liabilities arising under these terms and conditions or relating to the subject matter of these terms and conditions, including liabilities arising in contract, in tort (including negligence) and for breach of statutory duty.
  - c. To the extent that our website and the information and services on our website are provided free of charge, we will not be liable for any loss or damage of any nature.
  - d. We will not be liable to you in respect of any losses arising out of any event or events beyond our reasonable control.
  - e. We will not be liable to you in respect of any business losses, including (without limitation) loss of or damage to profits, income, revenue, use, production, anticipated savings, business, contracts, commercial opportunities or goodwill.
  - f. We will not be liable to you in respect of any loss or corruption of any data, database or software.
  - g. We will not be liable to you in respect of any special, indirect or consequential loss or damage.
  - h. You accept that we have an interest in limiting the personal liability of our officers and employees and, having regard to that interest, you acknowledge that we are a limited liability entity; you agree that you will not bring any claim personally against our officers or employees in respect of any losses you suffer in connection with the website or these terms and conditions (this will not, of course, limit or exclude the liability of the limited liability entity itself for the acts and omissions of our officers and employees).
